SPECIFICATIONS (CT, MA, ME, NH, RI, VT)**

In accordance with GR1111.4: Canada and NY are contiguous states. For contiguous state points New York includes New Jersey. Contiguous points earned in USEF/Equine Canada licensed competitions will only receive national points in USEF rated divisions.

JUDGING FOR ALL HUNTER SECTIONS:

To be judged on performance and soundness, suitability to count. Horses and Ponies are not required to jog for soundness.

ELIGIBILITY FOR ADULT AMATEURS: HUNTER, JUMPER AND EQUITATION: To be ridden by exhibitors who have reached their 18th birthday as of December 1 of the current competition year and who hold a current USEF Amateur certification. Open to horses and ponies.

PRE-CHILDREN'S HUNTER DIVISION CHJA

Open to junior riders who are eligible for Limit equitation over fences as of December 1 of the current show year and have never shown over fences exceeding 2'6" at a recognized horse show. Riders may show horses or ponies. Fence height 2'0". At the same show, horse/rider and pony/rider combinations may not cross enter into Children's Hunter Horse/Pony, Pony Hunters or any class where fences exceed 2'6". No combinations.

MODIFIED CHILDREN'S HUNTER CHJA

Open to junior exhibitors who have not yet reached their 18th birthday as of December 1 of the current competition year. Riders may not cross enter at the same competition into the Children's Hunter, Pony Hunter or any class/section where fences exceed 2'9". Fence Height: 2'6"

LOW CHILDREN'S HUNTER HORSE CHJA/USHJA

Open to junior exhibitors who have not yet reached their 18th birthday as of December 1 of the current competition year. Riders may not cross enter at the same competition into the Children's Hunter, Pony Hunter or any class/section where fences exceed 2'9". Fence Height: 2'6"

MODIFIED ADULT AMATEUR HUNTER CHJA

Open to adult amateur riders who, as of Dec. 1 of the current show year, have not shown in classes with fences 3' or higher at more than three recognized (USEF, CHSA) horse shows within the past two show years. Riders in this division may not compete in any class at the same show where obstacles exceed 2'6". May be combined w/ Mod. Children's Htr

LOW ADULT AMATEUR HUNTER CHJA, USHJA

Open to adult amateur exhibitors who have reached their 18th birthday as of December 1 of the current competition year. Riders may not cross enter into any class or section at the same competition where fences exceed 2'9". Fence Height: 2'6"

The Low Children's Hunter and Low Adult Amateur Hunter sections may be combined if there are fewer than three (3) entries in either section.

CHILDREN'S HUNTER HORSE DIVISION CHJA, USEF

To be ridden by exhibitors who have not reached their 18th birthday as of December 1 of the current competition year. Cross Entry: Riders cannot cross enter into any class where fences exceed 3'3" (exception: Equitation, Children's Jumpers, Pony Jumpers and the USHJA National Hunter Derby). Fence Height: 3'0" with spreads not to exceed fence height. Combinations will be permitted unless combined with Children's Hunter Pony. combining/Dividing Sections: the Children's Hunter Horse section may be divided by age of rider: Children's Hunter Horse 14 & Under and Children's Hunter Horse 15- 17. If there are fewer than three (3) entries in either age section, the two sections must be combined. The Children's Hunter Horse section may be combined with the Children's Hunter Pony, when There are fewer than three (3) entries in either section. Alternatively, the Children's Hunter Horse section may be combined with the Adult Amateur section when there are fewer than three (3) entries in either section. The Children's Hunter (horse & pony) section may be combined with the Adult Amateur section when there are fewer than three (3) entries in either section.

CHILDREN'S HUNTER PONY DIVISION USEF A, CHJA

To be ridden by exhibitors who have not reached their 18th birthday as of December 1 of the current competition year. Cross entry: Riders may only show one pony in either the 2'0" or the 2'6" height of the Children's Pony Hunter sections(s) when also competing on multiple ponies in the Regular or Green Pony Hunter sections(s). Riders may only show one pony in the Regular or Green Pony Hunter sections when competing on multiple ponies in the Children's Pony Hunter section(s) (exception: Model and Under Saddle classes). Horse/Pony: Ponies cannot cross enter into Regular and/or Green Pony Hunter section at the same competition. Fence Height: Small/Medium Ponies: 2'0" with spreads not to exceed height of fence, Large Ponies: 2'6" with spreads not to exceed height of fence. Distances will not be adjusted, combinations will not be permitted

ADULT AMAT. HUNTER DIV. CHJA, USEF A

To be ridden by amateurs who are no longer eligible to compete as junior exhibitors. Cross Entry: Riders may cross enter between the Adult Amateur Hunter and the Amateur Owner section if the rider owns the horse he or she is showing in the Adult Amateur section. Horses may not cross enter between the Adult Amateur and Amateur Owner Hunter sections at the same show. Horse-and-rider combination is not eligible for any other USEF rated classes in which fence height exceeds 3'0" (exception: Equitation 3'3", USHJA National Hunter Derby). Fence height: 3'0" with spreads not to exceed the fence height. Courses will not be adjusted for ponies. Combinations will be permitted.

OPPORTUNITY CONNECTICUT HUNTER LOW CHJA

Open to all horses. Fences 2'9". Champion and Reserve
5-6: CT Hunter over Fences
7: CT Hunter Under saddle

OPPORTUNITY CT TRAINING HUNTER, CHJA

Open to all horses or ponies. No age limitations and no rider restrictions. No restriction of horse/pony/rider into other divisions if otherwise eligible. Same horse/rider combination may not compete in more than one section per show. Fence Heights offered 18", 2' or 2'6"

Hunter Classics:

BIT'O STRAW HUNTER CLASSIC

Fences: 2'6" No cross entry of any pony/horse/rider into M & S Children's or Adult Hunter Classic. No cross entry of rider into any USEF rated Hunter Division.

EQUITATION CLASSES:

BEGINNER WALK-TROT EQUITATION CHJA

Riders 10 years of age and under who have not competed in any class requiring them to canter or jump at a recognized show. Riders may not compete in any short stirrup classes. Riders will be asked to walk and trot in both directions of the ring. They will be judged on position and ability to control their mount. Diagonals will be considered.

SHORT STIRRUP EQUITATION DIVISION - CHJA Open to riders 12 years and under who have never competed over fences exceeding 18" at a recognized show. Riders showing in this division may not compete in any other recognized division or recognized class in a show with fences exceeding 18" with the exception of pleasure and pet-type pony classes.

SHORT STIRRUP HUNTER DIVISION CHJA

Open to riders 12 years of age and under who have never competed over fence; exceeding 18" in a recognized show. Riders competing in this division may not compete in any other recognized division or class in the show where obstacles exceed 18" in height. Course not to exceed eight fences, not to exceed 18".

PRE-CHILDREN'S EQUITATION , CHJA

Open to junior riders who are eligible for Limit Equitation over fences as of December 1 of the current show year and have never shown over fences exceeding 2'6" at a recognized horse show. Riders may show horses or ponies. At the same show, riders may not cross enter into Children's Equitation, Children's Pony Hunter, Pony Hunters, any Medal Class over 2'0", or any class where fences exceed 2'6". Fence height 2'0". No combinations

MODIFIED ADULT AMATEUR HUNT SEAT EQUITATION, CHJA

Open to adult amateur riders who, as of Dec. 1 of the current show year, have not shown in classes with fences 3' or higher at more than three recognized (USEF, , CHSA) horse shows within the past two show years. Riders in this division may not compete in any class at the same show where obstacles exceed 2'6".

CHILDREN'S EQUITATION DIVISION

CHJA

Open to riders who are eligible for Children's Hunter, have not shown over a course where fences exceeded 3' at a recognized show, and have never shown in the Junior Medal Finals. Fences for horses and large ponies 2'6" and 2'0" for small/medium ponies

JUNIOR EQUITATION DIVISION CHJA

Open to all Junior riders that have not reached their 18th birthday. Riders cannot cross enter into the Children's Equitation. Fences not to exceed 3'.

ADULT AMATEUR HUNT SEAT EQUITATION CHJA, USEF

Open to amateur riders 18 years old and over. Fences to be 2'9" - 3'.

MEDAL CLASSES

Entry Fee for all Medal Classes: \$45.00

NHSA/ASPCA Maclay Class: 3'6". Flat phase 50/50.

Dover Saddlery/ US Equestrian Federation Hunter Seat Medal:

3'6" Over a hunter-type course.

NHS Hamel Foundation 3'3" Medal

Classes are open only to junior members of the USEF or Equine Canada who have not reached their 18th birthday in accordance with GR127 and who have never competed in any of the following National Equitation Finals with fences at 3'6": ASPCA Maclay Finals, US Medal Finals, USEF Talent Search (East or West), WIHS Equitation Classic Finals, Jump Canada Medal Finals or the North American Equitation Championship. Riders who compete in a NHS 3'3" Medal Class may show in any other classes for which they are eligible at the same horse show. Riders may not show in both the National Horse Show 3'3" Equitation Championship and the ASPCA Maclay Finals in the same competition year.

USHJA 3'3" Hunter Seat Medal—Fences 3'3"

The USHJA 3'3" Hunter Seat Medal is open to Junior Active Members of the USEF and USHJA. Foreign residents who are also members of USEF and USHJA will be eligible to compete. Eligible riders are those who have not competed in any of the following National Equitation Finals with fences at 3'6" within the same competition year including: ASPCA Maclay Finals, USEF Hunter Seat Medal Finals, USEF Show Jumping Talent Search Finals (East or West), WIHS Equitation Classic Finals, Jump Canada Medal Finals or the North American Equitation Championship.

Marshall & Sterling USEF Pony Medal:

This competition is an official US Equestrian Federation qualifying competition for the US Equestrian Federation Hunter Pony National Championships. . Open to Junior Members of USEF on ponies 14.2 hands and under. Riders entered in this class cannot cross enter into a USEF Medal Class at the same show. To be shown over a course of not less than six obstacles 2'3" for 12.2 hands and under ponies; 2'6" for 13.2 hands and under ponies; and 3' for ponies over 13.2 hands. Tests 1-19 may be required.

WIHS Pony Equitation: Fences 2'3", 2'6", 3'.

WIHS Equitation - one phase (hunter): Three members must complete the course. To be shown over a minimum of 8 jumps at 3'6".

MARSHALL & STERLING

Medal classes: Two or more tests of the top four competitors are required. The same horse must be used in all phases. To fill the class three riders must complete the course. The rider must be a member in order for points to count toward qualifying for the Finals. To be shown over a minimum of 8 fences. The same horse must be used in all phases. Only one rider per horse.

Marshall & Sterling Dover Adult Medal:

Fences 3'.

May only be combined with the Sore No More Children's Medal and M&S Children's Hunter Pony Medal.

Marshall & Sterling Sore No More Children's Medal:

Fences 3'. May only be combined with the Dover Adult Medal and/or Children's Hunter Pony Medal.

Marshall & Sterling 2'6" Children's Medal:

May only be combined with 2'6" Modified Adult Medal.

Marshall & Sterling Children's Pony Medal:

May only be combined with Sore No More Children's Medal and/or Dover Adult Medal.

Marshall & Sterling Junior Medal:

Fences 3'6".

May not be combined with any other M&S Medals.

Marshall & Sterling Jr/Amateur Horsemanship Medal:

Fences 3'3", flat phase required. Change of bridle between phases permissible, running martingales permitted.

CHJA MEDAL CLASSES

Riders must be members of CHJA and present their membership cards to the secretary. The classes consist of two phases, the first phase to be shown over obstacles. The Judge will then select at least six competitors, if available, to compete in the second flat phase, each to count 50%. The same horse or pony must be ridden by the same rider in both phases. To fill a class, three members must complete both phases of the class. Additional testing may be requested.

CHJA Pony Medal Class. Small and medium ponies to jump obstacles 2'0" in height, Large ponies to jump obstacles 2'6" in height.

CHJA Children's Medal. Open to Junior members of the CHJA who are eligible for Children's Hunter and who have not shown over a course at a Recognized show where fences exceeded 3'. If you have ever qualified for or shown in a 3' Equitation Final, including CHJA, you are not eligible for the Children's Medal. Fence height 2'6".

CHJA Junior Hunt Seat Medal. Fence height 3'. Open to Junior Members of the CHJA. b. The first phase is to be shown over a course of not less than eight obstacles, 3' in height. At least one combination, including one oxer is required. The course must contain at least two changes of direction (change of lead) after the first obstacle. c. Second (flat) phase is mandatory and will count 50%. d. Judges may require additional testing, using current USEF Tests 1-19.

CHJA Adult Medal. Open to Adult Amateur Members of the CHJA. b. The first phase is to be shown over a course of not less than eight obstacles, 3'0" in height and must contain one combination including an oxer. The course must contain at least two changes of direction (change of lead) after the first obstacle. c. Second (flat) phase is mandatory and will count 50%.

CHJA Modified Adult Medal: . Open to Adult Amateur Members of the CHJA who are eligible for Modified Adult Equitation. In addition, if the rider has qualified or shown in a 3' equitation Finals within the last two years including The CHJA Medal Finals, she/he is not eligible for the CHJA Modified Adult Medal qualifying class. b. The first phase is to be shown over a course of not less than eight obstacles, 2'6" in height. The course must contain at least two changes of direction (change of lead) after the first obstacle and no combinations.

CHJA Pre-Children's Medal: This class is open to Junior members of the CHJA who have not shown over fences exceeding 2' 6" at a Recognized Show. If a rider has ever qualified for or shown in a 2'6" Equitation final including the CHJA Children's Medal, they are no longer eligible for the CHJA Pre Children's Medal. The class consists of two phases. b. The first phase to be shown over a course of not less than eight obstacles at 2' in height. The course must contain two changes of direction after the first fence and no combinations are permitted.

THIS Children's Medal:

Fences 3'. Open to all Junior members of the USEF and Equine Canada who have never competed in any of the following National Equitation Final with fences at 3'6": Pessoa/US Medal; ASPCA Maclay; USEF Talent Search (East or West); Jump Canada Medal Finals; WIHS Junior Equitation Finals; Hunterdon Cup; North American Equitation Championship. To be shown over a minimum of eight fences 2'9" to 3' in height, spread not to exceed fence height. The course may be either a Jumper or Hunter type course and must include at least two changes of direction and a combination. Water obstacles (i.e.; water jump, liverpool) are not permitted. The top four riders are required to perform at least two individual tests from USEF Tests 1-19. An Open Numerical Scoring System must be used in the first round, with each rider's score announced at the completion of their round. There is no minimum requirement to fill the class. Approximately forty riders will be invited to compete in the finals and will be chosen as follows; the high point rider in each of the regional series will be invited, along with additional riders working from the top down on the National Standings list for the qualifying period. Any unfilled slots will be chosen by continuing down the National Standings list.

ARIAT/Farnham Adult Medal.

Open to Amateur Adult riders. Fences 3". Open to all Amateur members of USEF and Equine Canada who are eligible to compete in the Adult Amateur Hunter Section at this show (based on USHJA Zone specifications for the shows location.). **Additionally, a rider may not compete at the same horse show in any hunter or equitation class in which the jumps exceed three feet, three inches (3'3") or any jumper class set at 1.20m or higher, except the USHJA National Hunter Derby.** To be shown over a minimum of eight fences 2'9" to 3' in height, spread not to exceed fence height. The course may be either a Jumper or Hunter type course and

NHS THIS Adult Medal.

Fences 3'. To be judged on seat, hands, guidance and control of the horse. After completion of the jumping phase a minimum of twelve (12) riders, if available, are required to show at a walk, trot and canter. The flat performance of those riders selected to show in the flat phase shall count 50%. USEF Tests 1-18. A minimum of 3 riders are required to complete the course.

NEHC Medal Classes:

NEHC Adult Medal Open to adult amateur members of the New England Horseman's Council. All contestants are required to perform over at least eight fences set at a height from 2'9" to 3' with a combination and two changes of direction after the first obstacle. One or more individual tests of the top four contestants may be requested at the judge's discretion. (USEF current tests 1-19). To fill a class, at least four competitors must complete the course.

NEHC Junior Medal Open to Junior members of the New England Horsemen's Council who have not reached their eighteenth birthday. All contestants are required to perform over at least eight fences set to a height from 3' to 3'3" with a combination and two changes of direction after the first obstacle. One or more individual tests of the top four contestants may be requested at the judge's discretion. (USEF current tests 1-19). To fill a class, at least four competitors must complete the course.

If there are not 4 riders of either or both the Junior or Adult Hunt Seat Medal qualifying class, they can be combined to meet the 4 rider minimum. Riders would show at their respective heights. Junior Hunt Seat Medal riders. 10 points qualifies with a 1st place (10 points) or a 2nd place (5 points). So two 2nd places can qualify a junior rider.

Pleasure Classes

New England Horsemen's Council Open Pleasure Horse or Pony.

To be shown at a walk, trot or jog, canter or lope. Loose rein on command of judge only, but without loss of contact. Will be required to back. Shall be judged on manners, performance and quality, in that order. All horses shall be judged on their respective merits regardless of type.





RULES AND SPECIFICATIONS

ALL CLASSES ARE RUN ACCORDING TO CURRENT USEF, CHJA, AND NEHC, SPECIFICATIONS WHERE APPLICABLE

1. Every class offered herein which is recognized by CHSA & NEHC will be conducted and judged in accordance with their current rules. In order to compete for Annual Awards in these organizations membership is required. Membership is required to enter CHJA & NEHC Medal classes. Membership forms, rule books and class specifications are available at the Secretary's Stand and also www.chja.net and nehc.info. Points shall accrue upon receipt of the completed membership form and dues by the members show Secretary, or the postmark date of mailed application.
2. Non-schooling fee \$50.00 for those horse/ponies not shown in horse show.
3. Stabling. All stalls will be on first come, first served basis. The cost is \$150 for the show or \$100.00 for a day stall. Stalls MUST be reserved by the Monday previous to the show. Stalls are permanent in nature and include doors or gates. SHAVINGS NOT INCLUDED. Arrival time is no earlier than the Thursday before the show at 5:00 PM.
4. Prize money will be awarded at the Secretary's office following the completion of the division. It is the responsibility of the exhibitor to collect prize monies.
5. The Committee reserves the right to change or vary the courses at their discretion.
6. Warm-Up Classes will be held at the discretion of management, time permitting, at a fee specified in the class descriptions. Schooling before start of show will be held in main ring, from 7:00- 8:00 A.M.
7. Management reserves the right to cancel, combine or divide classes if warranted.
8. Scratches will be accepted only with a veterinarian's or medical certificate one hour before classes begin. No other scratches will be allowed except at the discretion of management. Absolutely no refunds on stalls. Scratch Fee: \$50.00
9. All entry blanks must be signed by the owner, trainer, rider, or parent/guardian (when applicable) prior to numbers being assigned.
10. There will be an Order of Go maintained by gate personnel.
11. If necessary, the management reserves the right to limit entries in classes due to time restraints. Entries **will** be allowed in such cases on a first come, first served basis. Management reserves the right to adjust the time schedule when necessary.
12. During judging, no one other than the rider(s) is allowed in the ring except on official business.
13. Exhibitors must be in proper attire for all classes.
14. Exhibitors are notified that any discourtesy or disobedience to the judges or officials on the part of an owner, rider or groom shall disqualify the horse, and the owner shall forfeit his entry and other fees.
15. A processing fee of \$50.00 applies to all non-negotiable checks.
16. All dogs must be leashed.
17. Every animal entered for competition shall be under the control of the Committee, but THE PINES, CHJA, USEF, and NEHC will in no way be responsible for any damage that may occur and it shall be a condition of every entry that each exhibitor shall hold THE PINES, CHJA, USEF, and NEHC as well as the Show Committee harmless for any loss or accident which may occur. Should any question or dispute arise, it shall be referred to the Show Committee whose decision shall be final.
18. All exhibitors in the Amateur sections of this show must present their Amateur Certification card before numbers are issued.
19. Measurement Cards. All exhibitors in the Junior/Pony/Children's Hunter Sections must present their Measurement cards at the Show Office before numbers may be picked up. All Junior/Pony/ Children's Hunters that do not have current measurement cards will be measured. Measurement time and place will be announced.
20. Post Entries. Post Entries will be accepted up to one hour before the class at regular cost plus an office charge of \$35.00 per Rated Division. No Post Entries will be accepted when such entry would require the dividing or re-dividing of a class section.
21. Entries close 48 hours prior to the show.
22. All classes in rated hunter divisions will be judged on performance and soundness unless otherwise noted.
23. All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. MOTORIZED VEHICLE STATEMENT

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

USEF Membership Statement

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above, Combined Driving Competitions at the Advanced Level, Dressage Competitions, Endurance Rides and Vaulting Competitions: (See GR828.4 of the Federation rules). Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent, at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR231) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes

"Every class offered herein which is recognized by the CHJA will be conducted and judged in accordance with the current CHJA Rules. To show in CHJA Medal classes, riders MUST be members. In order to compete for CHJA annual year-end awards, the owner of the horse or pony must be a member of the CHJA and the horse or pony must be registered with the CHJA. A copy of the CHJA Rule Book, class specifications, Medal class specifications, and membership applications are available at the show secretary's office and at www.CHJA.net."

- Continue to follow CT-160 - 0.7 mi
- Continue onto Tryon St - 0.2 mi
- Turn left onto Dug Rd - 0.2 mi

The Pines's driveway will be on your right. The farm is not visible from the road, but you will see a white rock marked 272, The Pines. If you continue onto a section of dirt road, you have gone too far.
