**PRE-CHILDREN'S HUNTER DIVISION CHJA, CHSA**

Open to junior riders who are eligible for Limit equitation over fences as of December 1 of the current show year and have never shown over fences exceeding 2'6" at a recognized horse show. Riders may show horses or ponies. Fence height 2'0". At the same show, horse/rider and pony/rider combinations may not cross enter into Children's Hunter Horse/Pony, Pony Hunters or any class where fences exceed 2'6". No combinations.

**MODIFIED CHILDREN'S HUNTER CHJA, CHSA**

Open to junior riders who are eligible for Children's Equitation. Open to horses or ponies. Fence height 2'6". Spreads not to exceed fence height. No combinations. At the same show, same horse/rider or pony/rider combination cannot enter any over fence classes exceeding 2'6". May be combined with Mod Adult Hunter if either section has less than 3 entries.

**MODIFIED ADULT AMATEUR HUNTER CHJA, CHSA**

Open to adult amateur riders who, as of Dec. 1 of the current show year, have not shown in classes with fences 3' or higher at more than three recognized (USEF, CHSA) horse shows within the past two show years. Riders in this division may not compete in any class at the same show where obstacles exceed 2'6". May be combined w/ Mod. Children's Htr

**LOW ADULT AMATEUR HUNTER CHJA, USEF**

Open to adult amateur exhibitors who have reached their 18th birthday as of December 1 of the current competition year. Riders may not cross enter into any class or section at the same competition where fences exceed 2'9". Fence Height: 2'6"

**LOW CHILDREN'S HUNTER HORSE CHJA, CHSA**

Open to junior exhibitors who have not yet reached their 18th birthday as of December 1 of the current competition year. Riders may not cross enter at the same competition into the Children's Hunter, Pony Hunter, or any class/section where fences exceed 2'9". Fence Height: 2'6"

The Low Children's Hunter and Low Adult Amateur Hunter sections may be combined if there are fewer than three (3) entries in either section.

To be shown by junior exhibitors. Junior exhibitors 15-17 years of age must be eligible for intermediate equitation over fences as of Dec. 1 of the current show year. #### **\$250 M&S/NAL ADULT AMAT. HUNTER CLASSIC**

Entry Fee: \$50.00. Entries must compete in at least 2 classes in the Adult Hunter Section. Prize Money \$75, \$55, \$25, \$25, \$25, \$20, \$12.50, \$12.50

#### **BIT'O STRAW HUNTER CLASSIC**

Fences: 2'6" No cross entry of any pony/horse/rider into M & S Children's or Adult Hunter Classic. No cross entry of rider into any USEF rated Hunter Division.

#### **EQUITATION CLASSES:**

##### **HUNT SEAT LEADLINE CHSA, CHSA, NEHC**

Open to children who have not yet reached their 7th birthday as of Dec. 1 of the current show year and have not competed in other than lead rein classes. Judged on hunt seat equitation. Ponies/horses to led by an adult.

##### **BEGINNER WALK-TROT EQUITATION CHJA**

Riders 10 years of age and under who have not competed in any class requiring them to canter or jump at a recognized show. Riders may not compete in any short stirrup classes. Riders will be asked to walk and trot in both directions of the ring. They will be judged on position and ability to control their mount. Diagonals will be considered.

##### **OPPORTUNITY SHORT STIRRUP EQUITATION DIVISION - CHJA** Open to riders 12 years and under who have never competed over fences exceeding 18" at a recognized show. Riders showing in this division may not compete in any other recognized division or recognized class in a show with fences exceeding 18" with the exception of pleasure and pet-type pony classes.

##### **SHORT STIRRUP HUNTER DIVISION CHJA**

Open to riders 12 years of age and under who have never competed over fence; exceeding 18" in a recognized show. Riders competing in this division may not compete in any other recognized division or class in the show where obstacles exceed 18" in height. Course not to exceed eight fences, not to exceed 18".

##### **PRE-CHILDREN'S EQUITATION , CHJA, CHSA**

Open to junior riders who are eligible for Limit Equitation over fences as of December 1 of the current show year and have never shown over fences exceeding 2'6" at a recognized horse show. Riders may show horses or ponies. At the same show, riders may not cross enter into Children's Equitation, Children's Pony Hunter, Pony Hunters, any Medal Class over 2'0", or any class where fences exceed 2'6". Fence height 2'0". No combinations

##### **MODIFIED ADULT AMATEUR HUNT SEAT EQUITATION, CHJA**

Open to adult amateur riders who, as of Dec. 1 of the current show year, have not shown in classes with fences 3' or higher at more than three recognized (USEF, , CHSA) horse shows within the past two show years. Riders in this division may not compete in any class at the same show where obstacles exceed 2'6".

##### **CHILDREN'S EQUITATION DIVISION**

CHJA

Open to riders who are eligible for Children's Hunter, have not shown over a course where fences exceeded 3' at a recognized show, and have never shown in the Junior Medal Finals. Fences for horses and large ponies 2'6" and 2'0" for small/medium ponies

#### **JUNIOR EQUITATION DIVISION CHJA**

Open to all Junior riders that have not reached their 18th birthday. Riders cannot cross enter into the Children's Equitation. Fences not to exceed 3'.

#### **ADULT AMATEUR HUNT SEAT EQUITATION CHJA, USEF**

Open to amateur riders 18 years old and over. Fences to be 2'9" - 3'.

#### **MEDAL CLASSES**

**Entry Fee for all Medal Classes: \$50.00**

#### **MEDAL CLASSES**

**NHSA/ASPCA Maclay Class:** 3'6". Flat phase 50/50.

**Dover Saddlery/ US Equestrian Federation Hunter Seat Medal:**

3'6" Over a hunter-type course.

#### **NHS Hamel Foundation 3'3" Medal**

Classes are open only to junior members of the USEF or Equine Canada who have not reached their 18th birthday in accordance with GR127 and who have never competed in any of the following National Equitation Finals with fences at 3'6": ASPCA Maclay Finals, US Medal Finals, USEF Talent Search (East or West), WIHS Equitation Classic Finals, Jump Canada Medal Finals or the North American Equitation Championship. Riders who compete in a NHS 3'3" Medal Class may show in any other classes for which they are eligible at the same horse show. Riders may not show in both the National Horse Show 3'3" Equitation Championship and the ASPCA Maclay Finals in the same competition year.

#### **IHSA/USHJA 3'3" Hunter Seat Medal—Fences 3'3"**

The IHSA/USHJA 3'3" Hunter Seat Medal is open to Junior Active Members of the USEF and USHJA. Foreign residents who are also members of USEF and USHJA will be eligible to compete. Eligible riders are those who have not competed in any of the following National Equitation Finals with fences at 3'6" within the same competition year including: ASPCA Maclay Finals, USEF Hunter Seat Medal Finals, USEF Show Jumping Talent Search Finals (East or West), WIHS Equitation Classic Finals, Jump Canada Medal Finals or the North American Equitation Championship.

#### **Marshall & Sterling USEF Pony Medal:**

This competition is an official US Equestrian Federation qualifying competition for the US Equestrian Federation Hunter Pony National Championships. Open to Junior Members of USEF on ponies 14.2 hands and under. Riders entered in this class cannot cross enter into a USEF Medal Class at the same show. To be shown over a course of not less than six obstacles 2'3" for 12.2 hands and under ponies: 2'6" for 13.2 hands and under ponies; and 3' for ponies over 13.2 hands. Tests 1-19 may be required.

#### **WIHS Pony Equitation: Fences 2'3", 2'6", 3'.**

**WIHS Equitation - one phase (hunter):** Three members must complete the course. To be shown over a minimum of 8 jumps at 3'6".

#### **MARSHALL & STERLING**

Medal classes: Two or more tests of the top four competitors are required. The same horse must be used in all phases. To fill the class three riders must complete the course. The rider must be a member in order for points to count toward qualifying for the Finals. To be shown over a minimum of 8 fences. The same horse must be used in all phases. Only one rider per horse.

#### **Marshall & Sterling Dover Adult Medal:**

Fences 3'.

May only be combined with the Sore No More Children's Medal and M&S Children's Pony Medal.

**Marshall & Sterling Pyranha Children's Horse Medal:**

Fences 3'. May only be combined with the Dover Adult Medal and/or Children's Pony Medal.

**Marshall & Sterling 2'6" Children's Medal:**

May only be combined with 2'6" Modified Adult Medal.

**Marshall & Sterling Children's Pony Medal:**

May only be combined with Pyranha Children's Medal and/or Dover Adult Medal. Small ponies 2', large ponies 2'6".

**Marshall & Sterling Junior Medal:**

Fences 3'6".

May not be combined with any other M&S Medals.

**Marshall & Sterling Jr/Amateur Horsemanship Medal:**

Fences 3'3", flat phase required. Change of bridle between phases permissible, running martingales permitted.

**CHJA MEDAL CLASSES**

**Riders must be members of CHJA and present their membership cards to the secretary.** The classes consist of two phases, the first phase to be shown over obstacles. The Judge will then select at least six competitors, if available, to compete in the second flat phase, each to count 50%. The same horse or pony must be ridden by the same rider in both phases. To fill a class, three members must complete both phases of the class. Additional testing may be requested.

**CHJA Pony Medal Class.** Small and medium ponies to jump obstacles 2'0" in height, Large ponies to jump obstacles 2'6" in height.

**CHJA Children's Medal.** Open to Junior members of the CHJA who are eligible for Children's Hunter and who have not shown over a course at a Recognized show where fences exceeded 3'. If you have ever qualified for or shown in a 3' Equitation Final, including CHJA, you are not eligible for the Children's Medal. Fence height 2'6".

**CHJA Short Stirrup Medal:** Fence height 18"

**CHJA Junior Hunt Seat Medal.** Fence height 3'

**CHJA Adult Medal.** Fence height 3".

Open to CHSA members and non-members. AT least 3 members must complete the class. The course must contain at least 2 USEF tests 1 -18. Riders may compete in only 1 CHSA Medal class per show.

**CHSA Short Stirrup Medal Class:** X -Rails 18"

**CHSA Pre -Children's Medal Class:** Fences 2'

**CHSA Children's/Adult Amateur Medal Class —2'3"**

**CHSA Children's Medal Class— 2'6"**

**THIS Children's Medal:**

Fences 3'. Open to all Junior members of the USEF and Equine Canada who have never competed in any of the following National Equitation Final with fences at 3'6": Pessoa/US Medal; ASPCA Maclay; USEF Talent Search (East or West); Jump Canada Medal Finals; WIHS Junior Equitation Finals; Hunterdon Cup; North American Equitation Championship. To be shown over a minimum of eight fences 2'9" to 3' in height, spread not to exceed fence height. The top four riders are required to perform at least two individual tests from USEF Tests 1-19. An Open Numerical Scoring System must be used in the first round. There is no minimum requirement to fill the class.

**ARIAT Adult Medal**

Open to Amateur Adult riders. Fences 3". Open to all Amateur members of USEF and Equine Canada who are eligible to compete in the Adult Amateur Hunter Section at this show (based on USHJA Zone specifications for the shows location.). **Additionally, a rider may not compete at the same horse show in any hunter or equitation class in which the jumps exceed three feet, three inches (3'3") or any jumper class set at 1.20m or higher, except the USHJA National Hunter Derby.** To be shown over a minimum of

eight fences 2'9" to 3' in height, spread not to exceed fence height.

### **NHS THIS Adult Medal.**

Fences 3'. To be judged on seat, hands, guidance and control of the horse. After completion of the jumping phase a minimum of twelve (12) riders, if available, are required to show at a walk, trot and canter. The flat performance of those riders selected to show in the flat phase shall count 50%. USEF Tests 1-18. A minimum of 3 riders are required to complete the course.

### **NEHC Medal Classes:**

**NEHC Adult Medal** Open to adult amateur members of the New England Horseman's Council. All contestants are required to perform over at least eight fences set at a height from 2'9" to 3' with a combination and two changes of direction after the first obstacle. One or more individual tests of the top four contestants may be requested at the judge's discretion. (USEF current tests 1-19). To fill a class, at least four competitors must complete the course.

**NEHC Junior Medal** Open to Junior members of the New England Horsemen's Council who have not reached their eighteenth birthday. All contestants are required to perform over at least eight fences set to a height from 3' to 3'3" with a combination and two changes of direction after the first obstacle. One or more individual tests of the top four contestants may be requested at the judge's discretion. (USEF current tests 1-19). To fill a class, at least four competitors must complete the course. If there are not 4 riders of either or both the Junior or Adult Hunt Seat Medal qualifying class, they can be combined to meet the 4 rider minimum. Riders would show at their respective heights. Junior Hunt Seat Medal riders. 10 points qualifies with a 1st place (10 points) or a 2nd place (5 points). So two 2nd places can qualify a junior rider.

**WEC Premier Equitation Cup** Open to all Junior members of the USEF and Equine Canada. To be shown over a minimum of eight fences 3'6" in height. The Under Saddle performance of those riders selected to show under saddle shall count 50%. A rider must complete both phases to be eligible for a placing. Only one rider per horse. The same horse must be used in all phases. Class to be judged in accordance with the current USEF Standards for equitation. USEF tests EQ113 permitted. Three riders must complete the course for the class to count.

### **Pleasure Classes**

#### **New England Horsemen's Council Open Pleasure Horse or Pony.**

To be shown at a walk, trot or jog, canter or lope. Loose rein on command of judge only, but without loss of contact. Will be required to back. Shall be judged on manners, performance and quality, in that order. All horses shall be judged on their respective merits regardless of type.

#### **HUNTER PLEASURE**

CHSA, NEHC

Open to all horses of a hunter type ordinarily used for pleasure purposes, with no limitations as to status of rider. Walk, trot, canter both ways. Light contact is required. Judged on manners, performance, quality, presence, substance and soundness.

#### **JUNIOR EXHIBITOR ENGLISH PLEASURE**

CHSA

To be shown at a walk, trot and canter. Entries may be asked to back and halt. To be judged on manners, performance, suitability. Martingales prohibited. To be ridden on a reasonably loose rein on command.

#### **ADULT ENGLISH PLEASURE**

CHSA

To be shown at a walk, trot and canter. Entries may be asked to back and halt. To be judged on manners, performance, suitability. To be ridden on a reasonably loose rein on command.

**Cynthia Jensen (CHSA) PLEASURE** No restrictions on horse or rider. Walk, trot, canter, may be asked to back. Extended gaits may be re-quested. To be ridden with reasonable loose rein on command. Judged on manners, performance and suitability.

**CHILDREN'S PLEASURE PONY**

CHSA, NEHC Open to ponies only. To be ridden by Junior riders at walk/trot canter both ways of the ring.

**QH HUNTER UNDER SADDLE**

CHSA, NEHC

Horses to be shown at a walk, trot, and canter both ways of the ring. Horses should back easily and stand quietly. Horses may change gaits at the walk or the trot at the judge's discretion. Light contact recommended. Horses may be required to hand gallop. Horses must be registered with the AQHA and shown under their full registered name (AQHA/USEF) with papers available.

**COLOR BREED PLEASURE**

CHSA, NEHC

Open to Palominos, Appaloosas, Buckskins, Paints & Pintos. Judged on best color example of breed.

**A. RULES AND REGULATIONS:** I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at [www.usef.org](http://www.usef.org), as amended from time to time.

**B. ACKNOWLEDGMENT OF RISK:** I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").



## RULES AND SPECIFICATIONS

ALL CLASSES ARE RUN ACCORDING TO CURRENT USEF, CHJA, AND NEHC, SPECIFICATIONS WHERE APPLICABLE

1. Every class offered herein which is recognized by CHSA & NEHC will be conducted and judged in accordance with their current rules. In order to compete for Annual Awards in these organizations membership is required. Membership is required to enter CHJA& NEHC Medal classes. Member-ship forms, rule books and class specifications are available at the Secretary's Stand and also [www.chja.net](http://www.chja.net) and [nehc.info](http://nehc.info). Points shall accrue upon receipt of the completed membership form and dues by the members show Secretary, or the postmark date of mailed application.
2. Non-schooling fee \$50.00 for those horse/ponies not shown in horse show.
3. Stabling. All stalls will be on first come, first served basis. The cost is \$150 for the show or \$100.00 for a day stall. Stalls MUST be reserved by the Monday previous to the show. Stalls are permanent in nature and include doors or gates.
- SHAVINGS NOT INCLUDED. Arrival time is no earlier than the Thursday before the show at 5:00 PM.
4. Prize money will be awarded at the Secretary's office following the completion of the division. It is the responsibility of the exhibitor to collect prize monies.
5. The Committee reserves the right to change or vary the courses at their discretion.
6. Warm-Up Classes will be held at the discretion of management, time permitting, at a fee specified in the class descriptions. Schooling before start of show will be held in main ring, from 7:00- 8:00 A.M.
7. Management reserves the right to cancel, combine or divide classes if warranted.
8. Scratches will be accepted only with a veterinarian's or medical certificate one hour before classes begin. No other scratches will be allowed except at the discretion of management. Absolutely no refunds on stalls. Scratch Fee: \$50.00
9. All entry blanks must be signed by the owner, trainer, rider, or parent/guardian (when applicable) prior to numbers being assigned.
10. There will be an Order of Go maintained by gate personnel.
11. If necessary, the management reserves the right to limit entries in classes due to time restraints. Entries **will** be allowed in such cases on a first come, first served basis. Management reserves the right to adjust the time schedule when necessary.
12. During judging, no one other than the rider(s) is allowed in the ring except on official business.
13. Exhibitors must be in proper attire for all classes.
14. Exhibitors are notified that any courtesy or disobedience to the judges or officials on the part of an owner, rider or groom shall disqualify the horse, and the owner shall forfeit his entry and other fees.
15. A processing fee of \$50.00 applies to all non-negotiable checks.
16. All dogs must be leashed.
17. Every animal entered for competition shall be under the control of the Committee, but THE PINES, CHJA, USEF, and NEHC will in no way be responsible for any damage that may occur and it shall be a condition of every entry that each exhibitor shall hold THE PINES, CHJA, USEF, and NEHC as well as the Show Committee harmless for any loss or accident which may occur. Should any question or dispute arise, it shall be referred to the Show Committee whose decision shall be final.
18. All exhibitors in the Amateur sections of this show must present their Amateur Certification card before numbers are issued.
19. Measurement Cards. All exhibitors in the Junior/Pony/Children's Hunter Sections must present their Measurement cards at the Show Office before numbers may be picked up. All Junior/Pony/ Children's Hunters that do not have current measurement cards will be measured. Measurement time and place will be announced.
20. Post Entries. Post Entries will be accepted up to one hour before the class at regular cost plus an office charge of \$35.00 per Rated Division. No Post Entries will be accepted when such entry would require the dividing or re-dividing of a class section.
21. Entries close 48 hours prior to the show.
22. All classes in rated hunter divisions will be judged on performance and soundness unless otherwise noted.
23. All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at [www.usef.org](http://www.usef.org).

## **MOTORIZED VEHICLE STATEMENT**

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

## **USEF Membership Statement**

**Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes**
